1. Solve the following system of linear equations:

$$6(ax + by) = 3a + 2b$$
; $6(bx - ay) = 3b - 2a$.

3(ax + by) - 3a + 2b, 3(bx - ay) - 3b - 2a.

If (x-4) is a factor of $x^3 + ax^2 + 2bx - 24$ and a-b=8, find the values of a and b.

- 2. Find the L.C.M of $2x^2 128$, $x^2 9x + 20$ and $x^2 16$.
- 3. Solve the following equation:

$$2\left(\frac{2x-5}{x+3}\right) - 3\left(\frac{x+3}{2x-5}\right) = 5$$

- 4. How many terms of the A.P 24, 20, 16,..... must be taken so that the sum may be72? Explain the double answer.
- 5. A C.D player is available for Rs 14,000 cash payment or Rs 4,000 cash down payment followed by five monthly instalments of Rs 2,200 each. Compute the rate of interest






In a rhombus ABCD, prove that $AB^2 + BC^2 + CD^2 + DA^2 = AC^2 + BD^2$

- 8. Solve graphically the system of linear equations: 2x + y = 8 and x + 1 = 2y. Also find the coordinates of the points where the lines meet the y-axis.
- 9. If $P = \frac{1}{x y}$, $Q = \frac{x^2 y^2}{x^2y xy^2}$ and $Q = \frac{1}{x y}$, express $P \times Q \div R$ as a rational expression in lowest terms.
- 10. Find the three terms in A.P, such that their sum is 27 and product is 648.

 Or

 For what values of n, the nth term of the series "3 + 10 + 17 +" and "63 + 65 + 67 +" are same?
- 11. AB is a diameter of the circle with centre O and chord CD is equal to radius OC. AC and BD produced meet at P. Prove that $LCPD = 60^{\circ}$.



12. A piece of cloth costs Rs 200. If the piece was 5m longer and each metre of cloth costs Rs 2 less the cost of the piece would have remained unchanged. How long is



the piece and what is the original rate per metre?

- 13. A sum of Rs 24,600 was borrowed at 5% p.a. compound interest. The loan was paid back in two equal instalments. Find the value of each instalment.
- 14. Construct a quadrilateral PQRS such that PQ = 4.5 cm, PS = 4 cm, SQ = 5.4 cm, QR = 6.3 cm and $LQ = 110^{\circ}$. Construct another quadrilateral P'QR'S' similar to the quadrilateral PQRS so that the diagonal S'Q = 7.2 cm.
- 15. A semi-circular thin sheet of metal of diameter 28 cm is bent into an open conical cup. Find the depth and capacity of the cup.
- 16. Prove the following identity:

$$\frac{\cot\theta + \csc\theta - 1}{\cot\theta - \csc\theta + 1} = \frac{1 + \cos\theta}{\sin\theta}$$

or

Without using trigonometric tables evaluate the following: $\cot\theta \cdot \tan(90^{\circ} - \theta) - \sec(90^{\circ} - \theta) \cdot \csc\theta + \sin^2 25^{\circ} + \sin^2 65^{\circ} + 3(\tan 5^{\circ} \tan 45^{\circ} \tan 85^{\circ})$


17. The following data shows the expenditure incurred by a person on the following items in a month .Draw a pie chart to represent the data:

- 19. The vertices of a triangle are (1, 2), (h, -3) and (-4, k). Find the values of h and k if the centroid of the triangle be at the point (5, -1)

20. Prove that the ratio of the areas of two similar triangles is equal to the ratio of the squares of their corresponding sides.

Using the above do the following: In fig. PQRS is a trapezium in which PQ // RS and PQ = 3RS. Find the ratio of the areas of Δ s POQ and ROS.




21. If two circles touch each other internally or externally, prove that the point of contact




lies on the lie joining their centres.

Using the above result prove the following. Two circles with centres O and O' and radii r_1 and r_2 touch each other externally at P. AB is a line through P intersecting the two circles at A and B respectively. Prove that OA // OB'.




22. A solid cone of height 12 cm and base radius 6 cm has top 4 cm removed as shown in the fig. Find the whole surface area of the remaining solid cone



Or

A conical vessel of radius 6 cm and height 8 cm is completely filled with water. A sphere is lowered into the water and its size is such that when it touches the sides, it is just immersed. What fraction of water overflows?



23. A tree breaks due to the storm and broken part bends so that the top of the tree touches the ground making an angle of 30^{0} with the ground. The distance from the foot of the tree to the point where the top touches the ground is 10m. Find the height of the tree.



or

23. The angle of elevation of the top of the tower from a point on the same level as the foot of tower is α , on advancing P metres towards the foot of the tower, the angle of elevation becomes β . Show that the height h of the tower is given by $h = p \tan \beta \tan \alpha \tan \beta - \tan \alpha$

Also determine the height of the tower when P = 150m, $\alpha = 30^{\circ}$ and $\beta = 60^{\circ}$.

24. Following are the marks obtained by 60 students in an examination.
